- Super Collision Damage Waiver (SCDW) will be availed at extra cost.
- In case of SCDW is not availed, the following insurance excess will be deducted in case of any accident/hit & run.
 Group B to F, DS AED 1500
 Group G, H, K AED 2500
 Group I, J AED 5000
 Group RS, R, S AED 2500
- PAI (Personal Accident Insurance) if availed will be charged extra as per vehicle type.
- Salik (toll) tax will be charged at AED 5 per crossing.
- A POLICE REPORT is mandatory for all accidents, breakdowns and damages to the vehicle. No replacement vehicle will be provided without a police report. In case the vehicle is impounded by the government authorities, Thrifty will charge rental till the vehicle is returned to Thrifty.
- Mandatory documents required:
 With Residence Visa: Passport copy, Emirates ID Copy, Driver's license and credit card
 With Tourist Visa: Passport copy with entry stamp, International driving license and credit card
- Minimum driver age: 21 Years.
- GPS/Child Seats: Available at special rates.
- Driving restrictions / Non coverage: Loss or damage to personal belongings or luggage is not insured. Vehicles are prohibited to be used for racing, towing other vehicles, or any activity that is considered against the UAE laws. Vehicles are prohibited to be driven while under the influence of alcohol or drugs. Vehicles are prohibited to be used for off-roading – INCLUDING 4WD VEHICLES.
- Driving to Oman is not permitted.
- Monthly mileage limits apply based on vehicles from 3000 kilometers to 5000 kilometers if monthly rental is avail.
- Delivery and collection is charge Dhs.30/- per transaction (Sharjah/Ajman)
